# Challenges

- NEC3 criteria not met for Clause 31 and Clause 32
- Highways England schedule quality metrics not met including elements of the DCMA 14 point check
- Highways England schedule coding and structure not compliant
- Schedule in MS Project and not held in Primavera P6
- Schedule not resource and cost loaded enabling Earned Value Analysis

#### Intervention

Through close consultancy and developing a fundamental understanding of the various projects Xacom were able to pinpoint the issue which essentially centred on a number of schemes not meeting both NEC3 and client requirements.

A detailed action plan was developed and the Xacom team worked closely with divisional personnel and were instrumental in developing programmes that met the NEC3 and client requirements for submission acceptance.

### Outcome

 Accepted Clause 31 and Clause 32 programmes that were in Primavera P6, fully resourced and cost loaded generating Earned Value data for analysis and reporting.
